

TERMS & CONDITIONS

4CC Christmas Lights Competition

The following terms and conditions apply for the Grant Broadcasters Christmas Lights Competition promotion on Classic Hits 4CC. These terms and conditions apply in conjunction with Grant Broadcasters General Contest Rules. Where there is any inconsistency, these terms and conditions will prevail.

1. DURATION

The active promotion will begin Monday, 16th November, 2020 and continue until the Monday 21st December, 2020. Duration may change without notice and at the discretion of Grant Broadcasters.

2. METHOD OF ENTRY

During registration period (16.11.20 to 2.12.20) Christmas enthusiasts are invited register their Christmas Lights Display on www.4cc.com.au. Registration period is open from Monday, 16th November 2020, closing Monday 2nd December 2020. Voting period is open from 4th December, 2020. Community will cast votes for their favourite Christmas Light display. Voting period closing 20th December, 2020. Entry method may change without notice and at the discretion of Grant Broadcasters.

3. PRIZE

- First Prize: \$150 visa card.
- Second Prize: \$100 Voucher visa card
- Third Prize: \$100 Voucher visa card

Prize is only available for a period of time (36 months from time of wining). Prize is not cash redeemable. Prize contents may change without notice and at the discretion of Grant Broadcasters.

4. SELECTION OF WINNERS

There will be three Major prize winners. Christmas Light display with the most votes will win first prize (\$150 Voucher). Christmas Light display with the second most votes from the community will win second prize (\$100 Voucher). Christmas Light display with the third most votes from the community will win third prize (\$100 Voucher) Winners will be notified of prize at the time of winning. Winner selection may change without notice and at the discretion of Grant Broadcasters.

5. NOTIFICATION

Prize winners will be notified at the time of winning.

6. INDEMNITY

All contestants release from, and indemnify Grant Broadcasters against, all liability, cost, loss or expense arising out of acceptance of any prize(s) or participation in the competition including (but not limited to) loss of income, personal injury and damage to property and whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise. By entering this competition, the entrant agrees to their voice and/or image to be used on air or in other marketing collateral (including social media).

7. ENTRY CONDITIONS.
